

## ACTION PISTOL – BARRICADE EVENT

### Before the competition:

- Your eye protection
- Your hearing protection
- Stopwatch
- Targets
- Be familiar with operation of the timer

### Check:

- Competitors in the correct bays,
- Competitors are wearing eye & hearing protection
- Range staff and spectators are wearing eye & hearing protection
- Check pistols and other equipment OK
- Competitors have pasted ID stickers on targets
- Competitors wearing Start Numbers if provided
- Each competitor has an observer

### Preparation:

Invite competitors to the 10 yard line

Observers to mount targets

Check the range is clear of personnel:

**"ARE YOU HAPPY WITH YOUR TARGETS"**

**"UNCASE FIREARMS & SIGHT PICTURE"** Allow competitors to settle in, targets are faced. Competitor and equipment must be inside the firing box.

**"LOAD & MAKE READY"** Competitors load, holster and assume the ready position. Turn targets away check time on timer, all Competitors assumed the ready position:

**10,15, 25 and 35 yards series:**

**"READY"** pause, check line **"STANDBY"** Targets to face in 3 seconds

Repeat the procedure. At the end of each series after all firearms are holstered. Invite Competitors:

**"MOVE BACK TO .. YARDS"** Competitors may ask for a sight picture at each distance, targets to be faced away at 15, 25 and 35 yards if sight picture is required.

**At the end of 15 yards series:** After all firearms are holstered

**"COMPETITORS DO NOT TOUCH YOUR FIREARMS OBSERVERS**

**CHANGE TARGETS"** After targets are changed, check they are fitted correctly **"are you happy with your targets"** – face them away.

**Check the range is clear of personnel:**

Move the competitors back to the 25 yard line, allow sight pictures if requested. Check timer time setting and carry on once all competitors assume the ready position.

**At the end of the 35 yards series:**

**"UNLOAD AND SHOW CLEAR, OBSERVERS CLEAR FIREARMS AND**

**INDICATE ONCE FIREARM IS CASSED"** Clear all pistols for casing and removal

**"RANGE IS CLEAR"**

Complete Range Report, and forward to Classification Office with targets

Penalties: 10 points for premature start, each procedural error, each extra round fired, each round overtime.

Observer role: Observe competitors for safety infringements, procedural errors, late shots, extra shots and not enough shots. Report any occurrence to the RO straight after the string in which it occurred. Mount and retrieve targets as required.



### Course of Fire:

#### 10 Yards series Standing only

6-shots in 5 seconds, 2 Strings

6-shots at either target from matching side of the barricade then;

6-shots at remaining target from matching side of barricade

#### 15 Yards series Standing only

6-shots in 6 seconds, 2 Strings

6-shots at either target from matching side of the barricade then;

6-shots at remaining target from matching side of barricade

Change targets

#### 25 Yards series Standing only

6-shots in 7 seconds, 2 Strings

6-shots at either target from matching side of the barricade then;

6-shots at remaining target from matching side of barricade

#### 35 Yards series Standing only

6-shots in 8 seconds, 2 Strings

6-shots at either target from matching side of the barricade then;

6-shots at remaining target from matching side of barricade

Collect all 4 targets

Target

Targets are scored at the Classification office

### The Start Position

**Both hands flat on the barricade**

**Metallic Match**

**Firearm must not touch the barricade**
